CENTRAL INTERCEPTOR

1. On the final day of the Central Interceptor hearing the Panel requested updated conditions to reflect the last minute changes recommended by Richard Blakey.

2. These are **enclosed**.

- 3. The version of consent conditions circulated by Mr Blakey as part of his reply on 13 August 2013 included three minor edits not previously suggested, and raised one new query. In particular, Mr Blakey:
 - (a) Suggested that "will" should be replaced with "shall" in Condition 1.11(h);¹
 - (b) Suggested that "and Auckland Council" should be added to Condition 1.20;²
 - (c) Suggested the date range in Condition 2.3 should be from 1 August to 31 December, rather than 30 November;
 - (d) Raised a query about how Conditions 6.2 6.8 (which are preconstruction and during construction conditions) could be met if the Stormwater - Permanent Works consents did not commence until the works were completed.
- 4. During our reply we indicated that Mr Blakey's edits in (a) (c) above were accepted. In relation to (d) above, we advised that the Stormwater Permanent Works consents were in fact both construction and operation related consents and that, as a consequence, they should not have the later commencement date previously suggested. We advised the conditions would need to be amended as follows:
 - (a) The list of consents in Condition 1.23 needed to be amended to include the Stormwater - Permanent Works consents;
 - (b) Conditions 1.24 and 1.25 are to be deleted;
 - (c) The edits to Condition 6.1 are no longer required.
