Volumetric charges - \$1.375 per 1000 litres

#### **Wastewater**

#### **Customers who have water meters:**

Fixed charge per meter: \$195 per year Volumetric charge: \$2.336 per 1000 litres

Domestic wastewater volume is calculated at 78.5 per cent of the incoming water volume, as measured by the water meter. This assumes that, on average, 78.5 per cent of the water that enters the home goes down the drain via showers, baths washing machines, dishwashers, toilets, sinks, etc.

# **Invoicing and payment**

We will send you a bill for your water, wastewater and other associated charges every month. Your bill will include a breakdown of how these charges are calculated. Charges associated with connections will be billed separately.

If you have trouble paying your bill please contact us. We will ensure that any customer unable to pay their bill can discuss options with us before we try to recover any outstanding payment.

#### Payment due date

Payment of your monthly bill is due within 21 days of the bill date. Payment of charges associated with connections is due within 14 days of the bill date.

#### Late payment fees

If you do not pay your monthly bill within 24 days of the due date, you may be charged a late payment administration fee of \$7 or 1 per cent of the overdue balance per month, whichever is greater.
